## International and Regional Officials Panel (IROP)

In de september 2019 is de KNCB een High Performance programma voor umpires gestart. Daartoe is een panel van umpires en match referees geformeerd dat in internationale wedstrijden kan staan. De International and Regional Officials Panel (IROP) zal de officials leveren voor de internationale wedstrijden van het Nederlands team en voor ICC toernooien. Zoals nu met super league wedstrijden tegen Ierland.

Tevens is de bedoeling dat de leden van de IROP zich zo ver mogelijk ontwikkelen.

Op dit moment wordt de IROP geformeerd door de ICC umpires Rizwan Akram, Adriaan van der Dries en Nitin Bathi. Daarnaast vormen Deepraj Das, Maulik Prabhudesai en Martin Hancock deel van de reserve panel. Zij kunnen op termijn ook tot de ICC panel toetreden. Naast deze umpires, zijn de match referees Rob Kemming en Chris Pickett, deel van de groep. De leden van IROP zijn gekozen op uitnodiging van de SRC en zijn voor een jaar lid. Ieder najaar wordt opnieuw gekozen.

De bedoeling van de IROP is om match officials te trainen en bij te staan bij hun ontwikkeling om zo de kwaliteit te verhogen.

Sinds vorig jaar is de groep regelmatig bij elkaar geweest (door corona noodgedwongen on-line bijeenkomsten) waar verschillende aspecten van umpiren aan bod zijn geweest.

De IROP staat onder leiding van de High performance manager van de KNCB Roland Lefebvre. Ruud Kaulingfreks is de Umpires liaison en managet de groep en David Jukes adviseert en helpt programma's op te stellen.

Helaas hebben, om persoonlijke redenen, Huub Jansen en Pim van Liemt zich uit de ICC panel teruggetrokken. Ze blijven gelukkig wel in de competitie umpiren.

### English summary

- KNCB High Performance programme for match officials began in September 2019. The International and Regional Officials Panel (IROP) will provide for Umpires and Match Referees in ICC tournaments and for matches involving the Dutch national teams.
- KNCB High Performance Manager Roland Lefebvre leads the IROP while Ruud Kaulingfreks manages the group with David Jukes as the advisor.
- Umpires are recommended to the panel by the SRC and there is continuous development and assessments through the year. The objective is to train and develop match officials and thereby lift the quality. The group meets regularly through virtual sessions in pursuit of development.
- ICC Umpires: Adriaan van den Dries, Nitin Bathi & Rizwan Akram
- Reserve Umpires: Deepraj Das, Martin Hancock & Maulik Prabhudesai
- Match Referees: Chris Pickett & Rob Kemming
- Huub Jansen and Pim van Liemt have withdrawn from the ICC Panel

**Na einde wedstrijd verplichtingen / Post match duties****-Frank van Lent****Na einde wedstrijd verplichtingen**

Natuurlijk is het leuk om de wedstrijd na te bespreken met zowel spelers, toeschouwers, andere officials en natuurlijk je collega, maar de volgende zaken dienen in ieder geval nog gedaan te worden.

- Kort evaluatiegesprek met de captains. Wat vonden zij ervan? Hebben zij nog ervaringen of tips die ze willen vertellen? Maar ook: heb jij als umpire nog iets wat je de captain wil vertellen?
- Kort evaluatiegesprek met je collega('s). Wat vonden zij ervan? Hebben zij nog ervaringen of tips die ze willen vertellen? Maar ook: had je voor de wedstrijd jezelf bepaalde doelen gesteld en die doelen gedeeld met je collega? Bijv. signaleren van hoeveel ballen te gaan als er een wide/no ball is gebowled.
- Overleg met je collega('s) over het invullen van het accommodatierapport. Wat viel jullie beiden op? Wie vult het in?
- Overleg met je collega('s) over het toekennen van de Fair Play cijfers. Wat viel jullie beiden op? Wie stuurt het op?
- In geval van bookings: vul samen alle formulieren in en schrijf een zo gedetailleerd mogelijk rapport, waarin tijdstippen, namen en zoveel mogelijk feiten staan.
- In geval van regen onderbrekingen of afgelastingen: maak samen een kort verslag en schrijf een zo gedetailleerd mogelijk op: bij elke onderbreking: tijdstip, stand, wie aan bat, weersituatie. Voeg de DLS berekening bij.

Tip: controleer de versie van de gebruikte DLS software (staat op de prints) en bij voorkeur laat een umpire aanwezig zijn bij het invullen van de juiste scores en onderbrekingen voor de juiste DLS target door de scorers.

**Post match Duties**

Obviously it is nice, when the match is finished, to discuss the match with players, spectators, other officials and off course your colleague, but remember you also need to perform below activities

- Short evaluation talk with the captains. What do they think of the match? Do they want to share experiences or tips? Also: maybe the umpires have something to share to the captains?
- Short evaluation talk with your colleague (s). What do they think of the match? Do they want to share experiences or tips? Also: maybe you shared some goals before the match was started, were you successful? Example: keep signalling how many balls to go if a wide/no ball was bowled.
- Discuss with your colleague on the ground report. Was anything noticed? Who will actually enter it in the system?
- Discuss with your colleague on the Fair play ratings. Was anything noticed? Who will actually email it?
- In case of bookings: together fill in the forms and write a detailed report, including all times, names and facts as much as possible.
- In case of rain delays or cancellations: together write a detailed report, including on each interruption: times, score, who is on strike, weather situation. Add the DLS calculation.

Tip: check the DLS software version used (is printed on the sheets). It is advisable to have one umpire present when the scorer actually performs the DLS calculation to check if the correct scores and interruptions are entered to get a DLS target.

**Fair Play Guidelines**

Het is gebleken dat, zeker voor nieuwere umpires, er behoefte is aan een uitleg hoe tot de juiste waardering te komen.

Wij adviseren deze berekening te gebruiken:

- Start vanaf 7 (minimaal 0, maximum 10)
- Applaus voor milestones v.d. tegenstander (bijv. 50 runs) of goede prestaties ("mooi schot") + 0,5
- Medeleven bij pech tegenstander (bijv. "jammer jongen", "pech gehad") + 0,5
- Felicitaties na afloop +0,5
- Thuisspelend team: Schone kleedkamers + 0,5
- Uitspelend team: Meewerken met thuisploeg om pitch te coveren en helpen opruimen +0,5
- Bijzonder sportieve zaken zoals batsman terug roepen na onterecht uitgeven, substitute fielden voor tegenstander +1
- Team niet compleet aanwezig voor start -0,5
- Treuzelen, langzaam spel, onnodig veel positiewijzingen tijdens de over -0,5 per keer
- Sarcasme in woord of gebaar naar teamgenoten -0,5 per keer
- Onvriendelijk commentaar over tegenstander of commentaar om tegenstander te beïnvloeden (unfriendly banter) -0,5 per keer
- Commentaar op umpirebeslissingen in woord of gebaar -0,5 per keer
- Gebruik van niet Engelse of Nederlandse taal terwijl wel Engels of Nederlands machtig -0,5 per keer
- Officiële boekingen (level 1-4) -1 per keer

**Fair Play**

Also this year, the Fair Play ratings must be awarded after each game.

Please send an email to [SRC@KNCB.NL](mailto:SRC@KNCB.NL) with the awarded Fair Play ratings as soon as possible, not later than 1 day after the match.

**Fair Play Guidelines**

We received questions, especially by newer umpires, for guidelines how to calculate a correct Fair Play rating.

We recommend using this calculation:

- Start from 7 (minimum 0, maximum 10)
- Applause for opponent's milestones (like 50 runs) or good performances (like "nice shot") + 0.5
- Compassion in case of opponent's bad luck (like "bad luck") + 0.5
- Congratulations after the match +0.5
- Home team: Clean dressing rooms + 0.5
- Away team: Cooperate with home team to cover pitch and help clean up +0.5
- Particularly sporty activities such as recalling batsman after unjust dismissal, substitute fielding for opponent's team +1
- Team not fully present at start time -0.5
- Dawdling, slow play, unnecessary often fielding position changes during the over -0.5 per incident
- Sarcasm in word or gesture to teammates -0.5 per incident
- Unfriendly comments about opponent or comments to influence opponent (unfriendly banter) -0.5 per incident
- Comments on umpire decisions in word or gesture -0.5 per incident
- Use of non-English or Dutch language while English or Dutch capable -0.5 per incident
- Official bookings (level 1-4) -1 per incident

## Cricket and officiating in Europe

The ACO has a significant number of members in Europe who umpire and score matches all over the continent. Adriaan van den Dries is a Netherlands umpire member and this year, for the first time, he was able to attend the ACO AGM even though he was in South Africa at the time. Because the AGM was streamed live on Zoom Adriaan was able to ask a question directly to Martin and, shortly after, Martin asked him to write this article about the various tournaments that are run across Europe and how they are officiated.

Adriaan writes “Working together with the boards of the European countries, the European Cricket Network organises various cricket tournaments including The European Champions League (ECL), the European Cricket Series (ECS) and, new for 2021, the European Cricket Championship (ECC). For the last one, an international tournament, the ICC granted permission.”

### THE TOURNAMENTS

The European Cricket League (ECL) is the Champions League of European Cricket and is a T10 tournament for European clubs who became champions in their countries. In 2019, 8 teams took part and it was officiated by umpires from the 8 participating countries. The championship was won by VOC Rotterdam and it was a big success as it was viewed on live TV and streamed around the world in over 120 countries by over 40 broadcasters.

Due to COVID the 2020 tournament was cancelled, but in 2021 an expanded competition is planned with 16 champions of their country due to participate including Swardstone from Norfolk representing England. The tournament in Spain runs from May 31<sup>st</sup> till June 25<sup>th</sup> and will again be extensively streamed throughout the world. You can get more information by Googling European Cricket League!

A second tournament started in 2020 called the European Cricket Series (ECS). This is also a T10 format but takes place throughout Europe, officiated by local umpires and streamed around the world. 700 matches were played in 17 countries all within the local COVID regulations – Austria, Belgium, Bulgaria, Cyprus, Czechia, Estonia, Finland, Germany, Hungary, Portugal,

Romania, Spain, Sweden and Switzerland. This was the biggest sport event in 2020 – there were 185 days of cricket with an average of 150k daily viewers on YouTube and Facebook. Since it was also streamed by Fancode in India the interest from the subcontinent was much bigger.

The ECS is due to start again in 2021 in Spain, followed by Italy, Austria and Germany – subject to COVID of course. A tournament in England is also planned but no dates are confirmed yet.

The ICC has just allowed the ECN to organise a third event, the European Cricket Championship (ECC), another T10 tournament for national teams which will be held in Spain from September 13 to October 8, 2021. In this tournament 15 countries will participate including National County Cricketers Association Representative XI (ECB Amateurs).

### OFFICIATING THE TOURNAMENTS

One of the goals of the European Cricket Network (ECN) is to help cricket grow in Europe and give players a chance to play in front of a bigger audience. In July 2020 I was contacted by the organisation and we discussed how we could raise the standards of cricket in the tournaments. I am a firm believer that if you want to raise the level of players you also must raise the level of the officials.

Instead of sending experienced overseas umpires to the tournaments, the ECN chose to invest in the local umpires by appointing myself, my colleagues from the ICC Development Panel and fellow ACO members, Heath Kearns (Jersey) and Alex Dowdalls (Scotland), as well as former Dutch manager / ex-ICC European match referee Rob Kemmings (Netherlands), to mento the local umpires. We also fulfilled the role of Tournament Referees.

In 2020 I was involved in 6 weeks of cricket during European Cricket Series tournaments in 4 cities in 4 countries – Dresden, Lisbon, Prague, and Barcelona. In Barcelona 5 weeks of cricket were organised in the Olympic baseball stadium. Together with Rob Kemming we worked there with a small group of umpires who were able to make major progress during this period. Also, we

organised together with the local committee a couple of meetings for the other local umpires who were not involved in the tournament, where we spoke about things like teamwork, preparation and fieldcraft.

Next to a half season in the Netherlands and the T20I tri-series in Luxembourg, the T10 tournaments of the ECS kept me involved in cricket

during last year which was heavily influenced by COVID. Let's hope the vaccinations will bring us all more cricket in the coming season. You can follow the activities of European cricket at:

**Wijzigingen reglementen 2021 en vragen (mei 2021)****-Jan Hilhorst**

Het spelreglement THEO is aangepast aan de ICC ODI reglementen en is nu alleen in het Engels.

De Laws zijn in 2017 en 2019 veranderd. Zie [hier](#).

Hier is een samenvatting van de aanpassingen:

- Het spelreglement THEO is nu een document "[KNCB PLAYING CONDITIONS THEO](#)" (voor Dames en lager klasse apart)
- Minimaal 8 spelers
- Pace of play 12.8. Minimum Over Rates: Ieder half uur aan de captains melden
- Spikes niet toegestaan op kunstgras of matten
- Er wordt een "Match Referee" aangesteld die beslist over het veranderen van veld of pitch, stoppen van een wedstrijd en waaraan alle rapporten over spelers wordt gestuurd via [SRC@KNCB.NL](mailto:SRC@KNCB.NL)
- Geen KNCB umpires aanwezig: zie THE UMPIRES 2.1. Appointment and attendance
- Law 42: Alleen level 4 wordt toegepast tijdens de wedstrijd. Level 1-3 alleen rapport
- Dames
  - 40 overs, 4 bowlers niet 5
  - Powerplay I in het dames reglement
  - No ball als de bal meer dan 2x stuit (Laws is meer dan 1x)
  - Max 2 extra's in a over

Binnengekomen vragen:

- Gebruik van buienradar bij onderbrekingen: Het is aan de umpires, eventueel samen met de groundsman te beoordelen wat de verwachtingen zijn en te bepalen hoe lang het kan duren voordat en wedstrijd kan worden herstart. Buienradar kan een hulpmiddel zijn maar is niet feilloos met de toekomst te voorspellen. De umpires mogen nooit buienradar bepalend laten zijn.
- Law 42 en Level 4 wel en Level 1-3 alleen rapport
  - Dit betekent dat Level 1-3 wel wordt genoteerd en gemeld aan de captains en in een rapport aan de Match Referee van de KNCB maar er worden geen penalty runs of 10 overs penalty time gegeven tijdens de wedstrijd. Wel bij Level 4 wordt een speler van het veld en de wedstrijd verwijderd.





## Changes to regulations and questions (May 2021)

The Match regulations THEO now comply with the de ICC ODI regulations and are only in English.

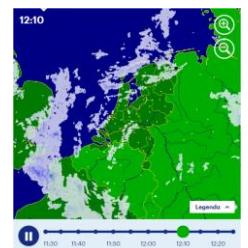
The Laws have been modified in 2017 in 2019. You can find them [here](#) .

The changes are:

- The match regulations THEO is now one document “[KNCB PLAYING CONDITIONS THEO](#)” (for Ladies and lower leagues there are separate documents)
- A Minimum of 8 players
- Pace of play 12.8. Minimum Over Rates: Inform the captain at least every half hour
- Spikes are not allowed on artificial turf or matting
- A “Match Referee” is appointed to decide on changing the ground or pitch, stopping or awarding a match and all reports are to be sent to him at [SRC@KNCB.NL](mailto:SRC@KNCB.NL)
- No KNCB umpires: see THE UMPIRES 2.1. Appointment and attendance
- Law 42: Only level 4 to be dealt with on-field. Level 1-3 only a report.
- Ladies
  - 40 overs, 4 bowlers not 5
  - Powerplay I in the regs
  - No ball if the ball bounces more than 2x (Laws is more than 1x)
  - Max 2 extra’s in an over

Questions received:

- Use of “buienradar” (Digital Weather reports) and interruptions: It is for the umpires, possibly together with the groundsman to decide on possible length of the interruption and rescheduling a starting time. Buienradar can be of assistance but is not absolute and cannot predict the future. De umpires must not let buienradar decide for them.
- Law 42: Level 4 can be implemented but Level 1-3 only a report



This means that Level 1-3 must be noted and communicated to the captains on-field and reported to the Match Referee of the KNCB but no penalty runs or 10 overs penalty time is awarded. A Level 4 sanction will be effected by removing the player from the field and the match.

In 2021 zijn alle SRC vergaderingen en de vergaderingen/Umpire Development meetings met de scheidsrechters vooraf aan het seizoen, i.v.m. de COVID19 restricties, virtueel via MS Teams gehouden.

Opvallend is dat de opkomst bij een virtuele meeting minstens zo groot is als bij een ouderwetse meeting in een zaaltje. Het lijkt dan ook logisch dat in de toekomst, als we elkaar ook weer live mogen ontmoeten, we ook de mogelijkheid moeten blijven aanbieden om virtueel te kunnen deelnemen.

Tijdens de Umpire development CPD meetings werden voornamelijk de regelwijzigingen van de afgelopen jaren en de verwachte wijzigingen voor 2021 doorgenomen (Law 42, Match Referee).

Daarnaast werden deze onderwerpen behandeld: goede eigenschappen van een umpire, samenwerking, umpires rapport, gedrag en teleurstelling.

- SRC samenstelling en rolverdeling
- Competitiereglement
- Umpire beschikbaarheid
- Starten lagere klassen en COVID restricties
- Captain's reports
- Accommodatie report and Fair Play

- Umpire cursussen en examens
- Umpire werving
- IROP



In 2021 all SRC meetings and Umpire development pre-season meetings with umpires were, due to COVID19 restrictions, held virtually using MS Teams.

Noticeable was that attendance was at least as high as compared to a regular off line meeting. It makes a lot of sense that in future, when regular in-person meetings are allowed again, we still need to offer the possibility to join the meetings

virtually too.

At the Umpire Development CPD meetings mostly past and future law changes were discussed (Law 42, Match Referee).

Next to that the following topics were also discussed: characteristics of an effective umpire, team working, umpires report, dissent and disappointment.

At the almost weekly SRC meetings the following topics were discussed:

- SRC composition and roles
- Playing conditions
- Umpire availability
- Start of lower leagues & COVID restrictions
- Captain's reports
- Accommodation reports and Fair Play
- Umpire kit
- Umpire courses and exams
- Umpire resourcing
- IROP

**Regenregels en ingekorte wedstrijden***(English version on next page)***-Jan Hilhorst***Aanwijzingen vanuit de SRC. 28-5-2021*

Veel van de wedstrijden die de afgelopen weken gespeeld zijn hebben te maken gehad met regen en de toepassing van de regenregels.

De regenregels die gevolgd dienen te worden zijn duidelijk (13.7.2 in [2021 - playing conditions THEO](#)) maar de interpretatie ervan heeft de afgelopen weken tot commentaar geleid.

Hoe we ermee om dienen te gaan is in lijn met ICC en ECB ACO en hier te vinden: [Guidance Notes.pdf](#) ([getthegameon.co.uk](http://getthegameon.co.uk)).

Belangrijkste regels zijn:

- **Umpires** zijn **eindverantwoordelijk** en alleen zij beslissen.  
Captains en groundstaff mogen mening en advies geven maar beslissen niet.
- **Safety** van iedereen (spelers, umpires, toeschouwers) heeft altijd de hoogste prioriteit.
- Probeer zoveel mogelijk de wedstrijd tot een **resultaat** te brengen, ook al betekent dit dat er lang gewacht moet worden.
- Umpires treden altijd samen, als **team**, op.
- Als er een **afwijking van de regels** is, zoals van regel 13.8 (extra uur), wordt dat vooraf doorgegeven, ook wanneer de regel weer wordt ingetrokken wordt dit vooraf doorgegeven. Een afwijking van de regels dient door de umpires **voor de toss** aan de captains worden gemeld.
- **Aftrek van overs** dient te worden uitgerekend via **rekensheet** op de KNCB site: [Microsoft Word - Rekensheet-af trek-overs-1e-en-2e-innings-in-TK-HK-en-EK-Model-2017.docx \(kncb.nl\)](#)
- Werk samen verschillende **scenario's** uit tijdens regenbreaks.
- Bij aftrek van overs **de scorers** informeren over aantal minuten verloren, nieuwe start en eindtijd en nog beschikbare overs en controleren dat zij dit correct in **Zie onderin de screenshots. Dit om te voorkomen dat er een verkeerde target en een verkeerd resterend aantal overs/ballen wordt getoond in de LiveStream.**
- Controleer of de juiste **versie van DLS** gebruikt wordt!  
Het DLS versienummer staat in de **titelbalk van de DLS software** en helemaal **onderaan in de print-outs** van de ball-by-ball sheets.

Als een wedstrijd wordt **ingekort of afgelast** door de regen, dienen de umpires na afloop altijd een **rapport naar de SRC** te sturen met daarin:

- Uitgebreid verslag van de gebeurtenissen, met daarin alle relevante tijdstippen, scores, situatieomschrijving, argumenten, beslissingen. **Zoveel mogelijk feiten, geen meningen!**
- Gebruikte (ingevulde) rekensheets van beide umpires
- Gebruikte (ingevulde) DLS berekening

De SRC gebruikt dit om na te gaan waar verbetering nodig is in opleiding en om onduidelijkheden op te sporen.

## Rain affected matches

-Jan Hilhorst

Many of the matches played in recent weeks were rain affected.

The rain rules to be used are clear (13.7.2 in [2021 - playing conditions THEO](#)) but interpretation of these rules has led to various comments in recent weeks.

We should act according to the guidelines from ICC and ECB ACO, which can be found here: [Guidance Notes.pdf](#) ([getthegameon.co.uk](http://getthegameon.co.uk)).

Main rules are:

- **Umpires** have **sole responsibility**, only they decide!  
Captains and ground staff are allowed to give opinions and advice, but are not allowed to make decisions.
- **Safety** of everyone (players, umpires, spectators) has always the highest priority.
- Try as much as possible to **get a result** of the match, even if this means everyone has to wait in the club house for a long time.
- Umpires need to act together, as one **team**.
- If there is a **change in the match regulations**, such as 13.8 (extra hour available), you will be notified in advance of the match. If the rule is withdrawn again, then too will you be notified in advance. Any change must be communicated **before the toss** by the umpires to the captains.
- **Deduction of overs** must be calculated using the calculation sheet on the KNCB site: [Microsoft Word - Rekensheet-aftrek-overs-1e-en-2e-innings-in-TK-HK-en-EK-Model-2017.docx](#)
- During rain breaks, calculate multiple **scenarios**.
- When overs have been deducted inform **the scorers** on minutes lost, new start and end time and how many overs left and check that this is correctly noted. **See below for screenshots. This is to ensure that incorrect Target and an incorrect number of available overs/balls are not shown in the LiveStream.**
- Check that the correct **version of DLS** is being used!  
The DLS version number can be found in the **title bar of the DLS software** and at the very **bottom of the print outs** of the ball-by-ball sheets.

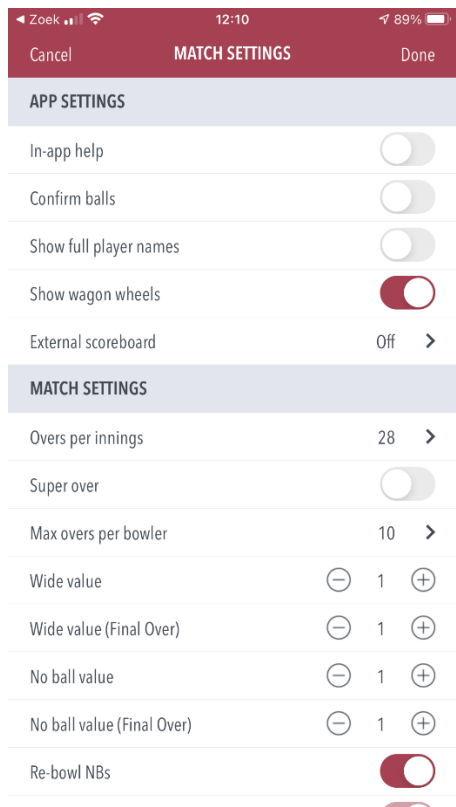
If a match is **rain affected or cancelled**, umpires must always send a report to the SRC afterwards including:

- Extensive report of the events, including all relevant times, scores, situation descriptions, arguments, decisions. **As many facts as possible, no personal opinions!**
- Used (completed) calculation sheets of both umpires
- Used (completed) DLS calculation.

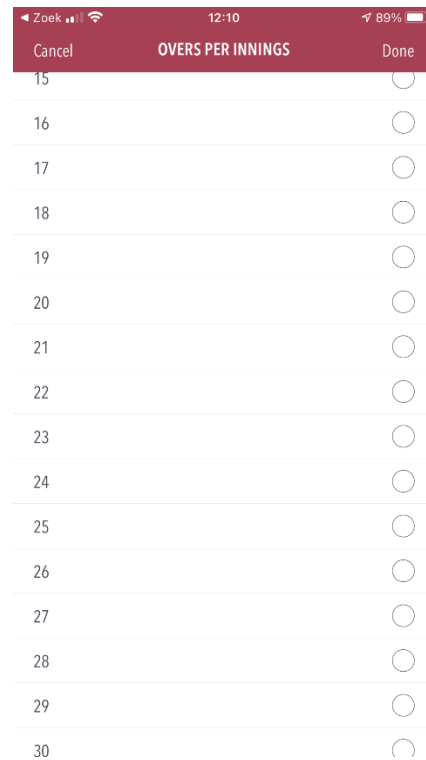
The SRC uses this information to determine where improvements are needed in training and to detect ambiguities.

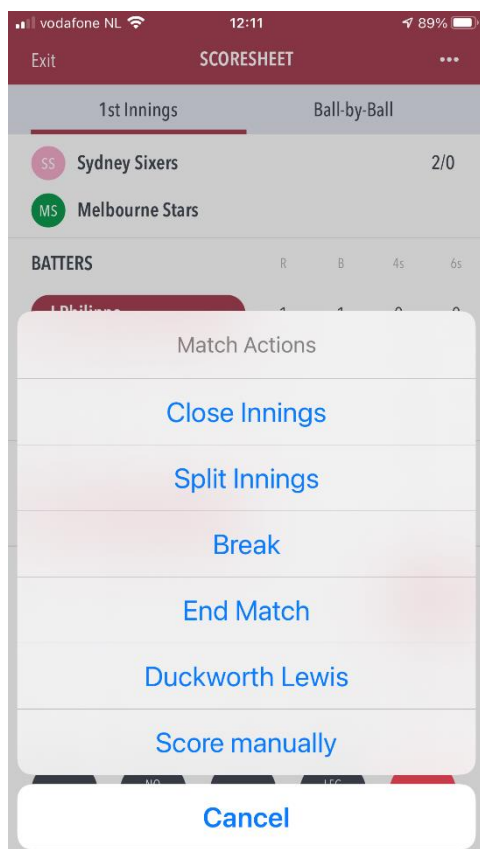
If overs are deducted before the first ball is bowled, change the number of available overs in the **Match Settings – Overs per innings** section.



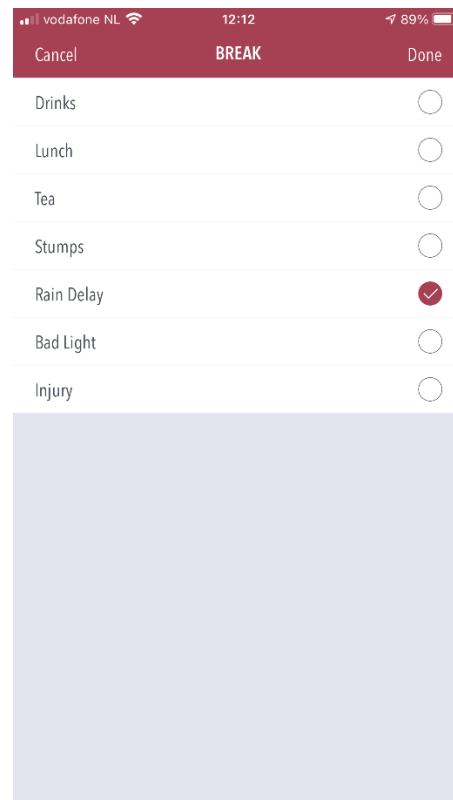
Select the correct overs amount



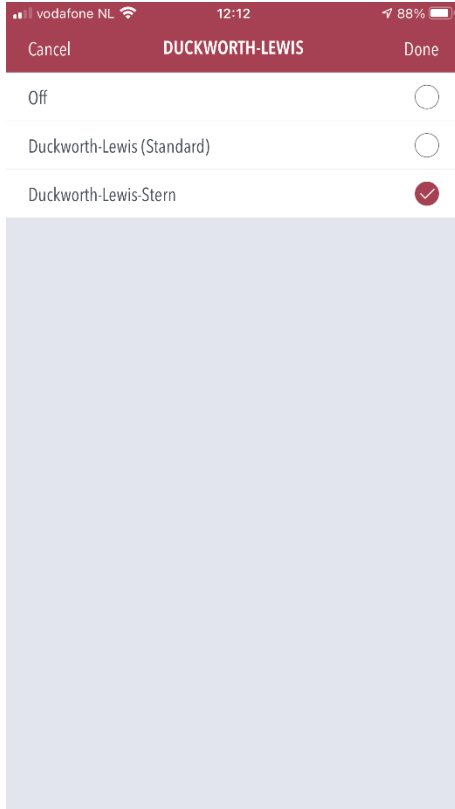
If overs are deducted before after ball are bowled, change the number of available overs in the **Match Actions - Break** section.



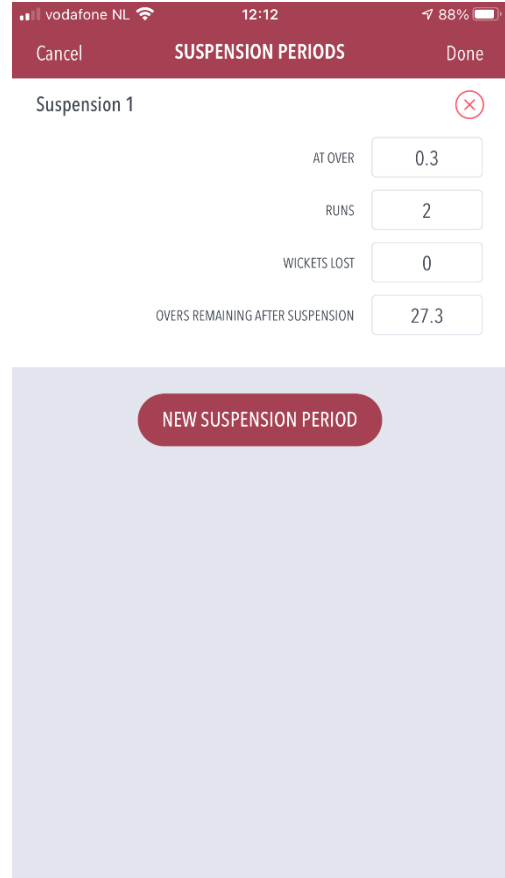
